About BRIGHT

The Barren River Initiative to Get Healthy Together (BRIGHT) Coalition is a non-profit health coalition that serves the 10-county Barren River region. These 10 counties include: Allen, Barren, Butler, Edmonson, Hart, Logan, Metcalfe, Monroe, Simpson, and Warren. The BRIGHT Coalition wants every resident in the Barren River Area Development District (BRADD) to have the best quality of life possible by ensuring a safe place to live, work, and play. Healthy individuals, families, and communities are the cornerstone of this vision. BRIGHT strives to create equal opportunities to be healthy with an emphasis on personal responsibility for health and wellness through collaboration among all stakeholders.

The BRIGHT Coalition formed in 2011 with seven community partners: Barren River District Health Department, Caverna Memorial Hospital, The Medical Center at Bowling Green, The Medical Center at Franklin, The Medical Center at Scottsville, Monroe County Medical Center, and TJ Samson Community Hospital. These stakeholders joined forces to answer the question, "How can leaders of South Central Kentucky's rural communities work together to improve our overall health status, strengthen the local economy, contribute to education successes, and improve the quality of life for all?". The BRIGHT coalition has since grown to over 47 organizations representing the ten counties in BRADD. The 2022-2025 Community Health Assessment (CHA) was conducted by the coalition to guide the community health improvement process for multiple organizations across the BRADD. This document details five priority health issues that BRIGHT selected after data analysis and utilized to develop a Community Health Improvement Plan (CHIP), included with the assessment.



Community Health Assessment Framework

Every three years, the BRIGHT Coalition completes a CHA for the BRADD region, which entails surveying the community, collecting data, and analyzing results to see what the biggest issues or needs are for the community. The data can then be used to design programs, implement services, develop policies, allocate community resources, and more. Throughout this resource, we've spotlighted local data that gives insight into our social and economic **context**, physical **environment**, everyday **behaviors**, and health **outcomes**.



BRIGHT's Priority Health Areas

Five **Priority Health Areas** were chosen by the coalition based on responses received from the 2022 Community Health Assessment Survey and local data. These priorities, along with our cross-cutting initiatives, will guide the coalition's work over the next three years. BRIGHT focuses on improving these areas to enrich the quality of life in the region.

Community Health Assessment Framework

For the 2022 CHA and CHIP, the coalition is using the Community Health Assessment Toolkit. This toolkit provides a nine-step process, as seen below. Steps one through six are the process for the Community Health Assessment, while steps seven through nine focus on the Community Health Improvement Plan.











Objective 1.3: By 2025, provide three avenues through which residents are empowered to grow their own fresh fruits, vegetables, and herbs.


Strategy 1.3.1: We will encourage the establishment of seed libraries throughout the BRADD region.

Physical Activity Responsible Agencies: BRIGHT

Goal 2: Increase residents' daily physical activity.

Objective 2.1: Advocate for useful sidewalks, greenways and trails in all 10 of our counties by 2025.

Strategy 2.1.1: We will advocate for policy to support clean and clear sidewalks.

Update: The BRIGHT Coalition continues to strengthen relationships with community partners (health coalitions, agencies, parks, and recreation, libraries, etc.) to promote physical activity.

Strategy 2.1.2: We will advocate for more sidewalks, greenways, trails and crosswalks, especially in our rural counties.

Objective 2.2: Decrease the percent of BRADD residents who are physically inactive by 10% by 2025.

Strategy 2.2.1: We will collaborate with community partners (health coalitions, agencies, parks and recreation, libraries, etc.) to promote physical activity.

Strategy 2.2.2: Promote physical activity events on social media to encourage participation.

Update: The BRIGHT Coalition has posted once per week on social media related to physical activity.

Goal 3: Improve quality of life for BRADD residents with diabetes and prediabetes.

Objective 3.1: Increase education on prediabetes and diabetes among BRADD adults, reaching 10,000 people per year.

Strategy 3.1.1: We will run a community education campaign on prediabetes and diabetes, primarily through social media.

Strategy 3.1.2: We will offer prediabetes classes to the public quarterly.

Strategy 3.1.3: We will promote Diabetes Self-Management Education and Support (DSMES), Diabetes Prevention Programs (DPP), and Medical Nutrition Therapy (MNT) to BRADD residents. We will aim to increase referrals by 10% for DSMES classes each year based on a current number of zero.

Objective 3.2: Increase screenings for prediabetes and diabetes among BRADD adults by 10% each year.

Strategy 3.2.1: We will provide the prediabetic risk assessment and/or blood glucose testing screenings to residents at various events and health fairs.

Strategy 3.2.2: Allen County Health Department will pilot a Diabetes Prevention Program with Monroe County Hospital.

*BRIGHT has decided to combine the Tobacco Workgroup with the Substance Use Workgroup for the next Community Health Improvement cycle.

Goal 4: Reduce rates of tobacco use across BRADD.

Objective 4.1: Reduce the rate of vaping among BRADD adolescents by 10% by 2025.

Update: New Kentucky Incentives for Prevention (KIP) not completed until Fall 2024. Several of our schools have offered the "Hidden in Plain Sight" presentation by a local State Trooper.

Strategy 4.1.1: We will help educate parents and guardians about the risk and appearance of vaping products.

Update: Barren River District Health Department (BRDHD) provided vaping prevention education classes at the 6th grade health fair at Franklin-Simpson Middle School, Community Health Fairs in Simpson and Logan Counties, Stevenson Elementary in Logan for K-5th grade, and Lewisburg Elementary/Middle School.

- Glasgow High school (Barren) 85 freshman were educated on vaping and tobacco dangers.
- Caregivers Meeting Tobacco and vaping education and dangers taught to 30 individuals.
- Metcalfe County High School —114 Freshman were taught vaping and tobacco use dangers.
- 4 FBLA students at Caverna Independent Schools partnered with a BRDHD Health Educator for a tobacco/vaping dangers presentation and interview. The students were given resources and documents pertaining to QUIT NOW and My Life My Quit.
- 142 Hart County 8th graders were educated on on vaping and tobacco dangers.

- Promoted the My Life, My Quit Program and/or 1-800-Quit Now programs at the following events: Community Baby Showers, Family Wellness/Mental Health nights at Bristow Elementary, Moss Middle, Richpond Elementary, Rockfield Elementary, South Warren High School, and community events at the Community Health and Wellness Expo and The Foundry.

Strategy 4.1.2: We will provide education through school events, classes, in-school flyers, health fairs, media, and social media on the dangers of tobacco use, with an extra focus on vaping. **Update:** Educational engagements listed above.

Strategy 4.1.3: We will host an anti-vaping art competition for adolescent residents.

Strategy 4.1.4: We will help strengthen 100% tobacco-free schools. (See next page for outcome measures.) **Update:** Tobacco-free campus signs posted at Butler County Schools, Logan County Schools and Russellville Independent Schools.

Goal 4: Reduce rates of tobacco use across BRADD.

Objective 4.2: Increase the number of BRADD residents who attend tobacco cessation counseling by 10%.

Strategy 4.2.1: We will promote cessation programming for school-aged tobacco users.

Update: We are offering both school aged tobacco and vape use education.

Strategy 4.2.2: We will offer 1:1 tobacco cessation services.

Update: Classes are offered, participation has been low.

Goal 5: Protect residents from second-hand smoke.

Objective 5.1: Have 3 smoke-free cities, towns, or counties in BRADD by 2025.

Update: Glasgow and Bowling Green were successful!

Strategy 5.1.1: We will advocate for a smoke-free ordinance in Scottsville, the county seat of Allen County.

Strategy 5.1.2: We will advocate for a smoke-free ordinance in Franklin, the county seat of Simpson County.

Strategy 5.1.3: We will run a media/social media campaign on the dangers of secondhand smoke during July 2023.



Goal 6: Reduce overdose deaths in BRADD.

Objective 6.1: Increase the number of Syringe Services Programs (SSP) in BRADD to 5 and 1 mobile unit by 2025. **Update:** Barren River District Health Department has four Syringe Services Programs (SSP) in Barren, Hart, Warren, Edmonson, and Logan counties.

Strategy 6.1.1: We will find suitable locations to run the mobile unit to increase SSP's reach in the community.

Strategy 6.1.2: We will get approval for SSP in Horse Cave, Edmonson and Allen County.

Update: Hart, Edmonson, and Logan Counties SSP's have been approved.

Objective 6.2: Increase Narcan accessibility in the BRADD area.

Update: Barren River District Health Department received a Naloxbox grant.



SSP Saves Lives

Strategy 6.2.1: We will increase access to Narcan in post-secondary settings (SKyCTC and WKU campuses). **Update:** Barren River District Health Department has increased access to Narcan in post-secondary settings such as Western Kentucky University. Barren River District Health Department (BRDHD) and UK Target 4 Outreach has provided around 50 units of Naloxone to WKU for residence halls.

Strategy 6.2.2: We will increase Narcan distribution in workplace environments.

Update: BRDHD has trained staff at a local church, Warren County Public Library, Hill's Pet Nutrition, Warren County Parks and Recreation, Electrical Plant Board (EPB), Bluegrass Professional Counseling, Transportation Department #4, and Mammoth Cave National Park. Trainees are provided with a free box of Naloxone. Approximately 75 units of Naloxone have been provided to worksites from BRDHD.

Strategy 6.2.3: We will provide education on how and when to use Naloxone.

Update: As stated above, the BRIGHT Coalition is actively providing education on how and when to administer naloxone on an as-requested basis.

Goal 8: Educate the BRADD region on the importance of mental health awareness to decrease stigma (social media, website, speakers at coalition meetings).

Objective 8.1: Increase awareness of the importance of mental health.

Strategy 8.1.1: Decrease the stigma of mental health through social media posts, the BRIGHT Coalition website and mental health speakers at the BRIGHT Coalition meetings.

Strategy 8.1.2: Help educate our region about defining a mental health issue or disorder through mental health speakers at the BRIGHT Coalition meetings. The BRIGHT Coalition will also share information about mental health disorders on social media, website and educational opportunities.

We will partner with our community organizations, leader and advocates to create community engagement in the mental health side of the BRIGHT Coalition. The BRIGHT Coalition will be sensitive to the needs of individuals who have experienced trauma. There will be resources made available in a variety of channels including online, community centers, healthcare centers, and workplaces to reach diverse populations. The BRIGHT Coalition will continue to promote empowerment and self-advocacy when it comes to mental health and help lead community members to seek appropriate help when needed.

BRIGHT's Cross-Cutting Goals and Strategies

Goal 7: Use a Health in All Policies (HiAP) approach, both in internal policies and in external policy advocacy.

Goal 9: Support community projects and collaboration.

Update: BRIGHT provided grant three \$500 award opportunities at the 2023 June workshop. Three agencies were awarded.

BRIGHT Mini-Grant Success Stories

Program Name: BG Refuge Soccer Club **Grant Funding Period:** July–September 2023

Funding

The funding from BRIGHT Coalition's mini-grant was allocated towards Refuge Bowling Green's soccer program. The funds assisted in providing approximately 75–80 Afghan children transportation to go to and from practice twice a week from July–September. The funds were also used to purchase soccer balls and healthy snacks for the children.



Impact

The BRIGHT Coalition's mini-grant promoted the overall success of our soccer program. Because of the support we were able to receive to keep the program running effectively, we were able to not only provide refugee youth with opportunities for physical activity and healthy competition, but we were also able to implement early intervention. Through the soccer program, we were able to collaborate with a local mental health organization, KY STEPS, to host a class on alcohol/drug abuse and prevention, as well as a class on tobacco and vape use.

Program Name: Delafield Co-Op Market **Grant Funding Period:** July-September 2023

Funding

Grant funding assisted with operational needs for kickstarting the Delafield Co-op Market. The Delafield Co-Op Market is a neighborhood micro-grocery store located in the heart of Bowling Green's West End. We pride ourselves on sourcing the freshest items from local farmers, growers, and makers. Operated by HOTEL INC, the Co-Op Market supports an underserved population by providing access to healthy, locally-grown food items in addition to many of your usual grocery staples.

Grant funding assisted with providing "Silver Sneakers", a class for senior adults, one to two days per week. Classes will be offered before and after lunch that is already provided.
