## **DISTRICT COVID-19 UPDATES**

The Barren River District Health Department has confirmed a total of 19,477 cases, 16,515 of which have recovered. We have 221 deaths reported from COVID-19. We stand in solidarity with those affected during these difficult times. See the breakdown of numbers by county below. Please note that a decrease in numbers is due to the county of residence or case status being corrected/updated from what was previously reported.

Vaccination clinics started on Wednesday, December 23<sup>rd</sup>, less than 24 hours after receiving the first shipment of the vaccine. The health department continues to get the vaccine out as quickly as possible into the arms of those individuals that have been designated to receive it. Vaccination clinics have been held in each of the eight counties that Barren River District serves. The Barren River District Health Department is currently vaccinating non-hospital health care workers and first responders.

Norton Call Center has been set up for the public that have questions about the COVID-19 vaccine. The call center is open 24 hours a day/7 days a week and can be reached at 1-800-722-5725.

In order to slow the spread of COVID-19, we must continue to follow recommendations provided by the CDC, the state, and Governor Andy Beshear.
